NOTICE OF APPLICATION AND HEARING FOR AN ELECTRICITY DISTRIBUTION RATE CHANGE

Toronto Hydro-Electric System Limited

Toronto Hydro-Electric System Limited has applied to the Ontario Energy Board for permission to change its delivery charges effective June 1, 2012, May 1, 2013 and May 1, 2014. The application was filed on May 10, 2012 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (Schedule B) and the Board's Incentive Regulation Mechanism framework.

Delivery charges are one of four regular items on Residential and General Service customers' electric bills and vary depending on the amount of electricity consumed. **If the application is approved as applied for, the monthly bill for a Residential customer who consumes 800 kWh per month will increase by about \$4.95 in 2012, \$2.41 in 2013 and \$0.95 in 2014 respectively. The monthly bill for a General Service customer consuming 2,000 kWh per month and having a monthly demand of less than 50 kW would increase by about \$12.04 in 2012, \$5.22 in 2013 and \$2.20 in 2014 respectively.** The proposed changes to the Delivery charges are separate from other potential changes to the electricity bills, which are not affected by this application.

All letters of comment or letters requesting observer status will be placed on the public record, which means that the letters can be seen at the Board's offices and will be available on the Board's website. Before placing the letters on the public record, the Board will remove any personal (i.e. not business) contact information from the letters (i.e. the address, fax number, phone number, and e-mail address of the individual). However, the name of the individual and the content of the letter will become part of the public record.
