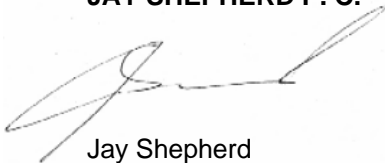
Re: EB-2012-0126 – Sudbury 2013 Rates – SEC Cost Claim
