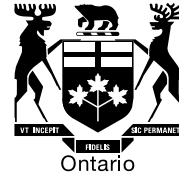

LETTER OF DIRECTION

The Ontario Energy Board (OEB) has now issued its Notice of Hearing (Notice) for London Hydro's 2017 cost of service distribution rates application. 1. No later than the date the Notice is posted on London Hydro's website in accordance with paragraph 2, to arrange for the service of each of the enclosed English and French versions of the Notice, in the exact form accompanying this letter and the application and the evidence, directly on all intervenors of record in London Hydro's previous cost of service rate proceeding EB-2012-0146, namely:

Vulnerable Energy Consumers' Coalition

2. To make a copy of both the English and French versions of the Notice, the application and evidence, and any amendments thereto, available for public review at London Hydro's office and in a prominent place on London Hydro's website.
3. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1 and 2 above immediately thereafter.
4. To provide a copy of the Notice, application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
