**E.L.K. Energy Inc.**

**Application to amend licensed service area in  
Schedule 1 of electricity distribution licence  
ED-2003-0015**

**PROCEDURAL ORDER NO. 2**

**November 1, 2016**

E.L.K. Energy Inc. (ELK) filed a complete application with the Ontario Energy Board (OEB) on June 21, 2016 under section 74 of the *Ontario Energy Board Act, 1998* for an order amending ELK's licensed service area in Schedule 1 of its electricity distribution licence ED-2003-0015.

Through the application, ELK seeks to expand its licensed service area to include specific lands currently located in the licensed service area of Hydro One Networks Inc. (Hydro One). Specifically, ELK wishes to supply and provide electricity distribution services to a proposed commercial development, in Hydro One's licensed service area, which is being developed by Sellick Equipment Limited.

A Notice of Application and Hearing was issued on July 26, 2016. Procedural Order No. 1 issued on August 9, 2016, made provisions for interrogatories on ELK's evidence, the filing of evidence from intervenors and interrogatories on that evidence, and written submissions. Pursuant to Procedural Order No 1, OEB staff and Hydro One filed their respective interrogatories on the application, to which ELK filed its responses on September 8, 2016. On September 22, 2016, Hydro One filed its evidence regarding the application. On October 6, 2016, OEB staff and ELK filed their respective interrogatories on Hydro One's evidence. Hydro One replied to OEB staff and ELK's interrogatories on October 20, 2016.

On October 6, 2016, ELK filed updated evidence which included an amended Offer to Connect issued to Sellick Equipment Limited on October 3, 2016.

The OEB is making provision for the following matters related to this proceeding to address the new evidence that ELK has filed.

**IT IS THEREFORE ORDERED THAT:**

1. Orders 6 and 7 of Procedural Order No. 1, outlining dates for submissions and responses, are cancelled.
2. Intervenors and OEB staff who wish information and material from the applicant that is in addition to the updated evidence filed with the OEB on October 6, 2016, and that is relevant to the hearing, shall request it by written interrogatories filed with the OEB and delivered to the applicant by **November 4, 2016**.
3. The applicant shall file complete responses to the interrogatories with the OEB and deliver them to all intervenors by **November 10, 2016**.
4. Any written submission from intervenors or OEB staff must be filed with the OEB and delivered to the applicant and all intervenors by **November 18, 2016**.
5. Any written response from the applicant must be filed with the OEB and delivered to all intervenors by **November 30, 2016**.

All filings to the OEB must quote the file number, EB-2016-0155, be made in searchable/ unrestricted PDF format electronically through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
