

**Oshawa PUC Networks Inc.**

**Application for electricity distribution rates beginning  
January 1, 2018 and January 1, 2019**

**PROCEDURAL ORDER NO. 2  
November 3, 2017**

Oshawa PUC Networks Inc. (Oshawa PUC) filed a Custom Incentive Regulation Mid-Term Update application with the Ontario Energy Board (OEB) on July 4, 2017 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that Oshawa PUC charges for electricity distribution, to be effective January 1, 2018 and January 1, 2019.

In accordance with Procedural Order No. 1 written interrogatories were filed by OEB staff and intervenors on October 11, 2017 and October 13, 2017, respectively. Oshawa PUC responded to the interrogatories on October 27, 2017. As some of the interrogatories require clarification, the OEB has provided for a conference call with OEB staff, Oshawa PUC, and intervenors. Procedural dates for submissions are revised.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

**IT IS THEREFORE ORDERED THAT:**

1. OEB staff shall schedule a teleconference with Oshawa PUC and intervenors to clarify the interrogatory responses and document undertakings as required on **November 10, 2017**.

2. Oshawa PUC shall file with the OEB complete responses to any undertakings and serve them on all intervenors and OEB staff by **November 15, 2017**.
3. Any written submission by OEB staff and intervenors shall be filed with the OEB and delivered to all intervenors and OEB staff by **November 22, 2017**.
4. Oshawa PUC may file a written reply submission with the OEB, and deliver it to all intervenors and OEB staff by **November 29, 2017**.

All filings to the OEB must quote the file number, EB-2017-0069, be made in searchable / unrestricted PDF format electronically through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.oeb.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
