AFFIDAVIT OF SERVICE

Notice of Service by Tribute Energy Storage Inc. Regarding the Application to the Ontario Energy Board for an Order to Revoke the Designation of the Natural Gas Storage Areas Known as the Bayfield & Stanley 4-7-XI Reservoirs Under Section 36.1(1)(b) of the OEB Act, OEB File Number: EB-2019-0287 Dated January 24, 2020.

I, **Stephen J Sangiuliano**, located in Vaughan, Ontario, Canada, acting Director of Project Management for Tribute Energy Storage Inc. ("TESI", or "the Corporation"),

MAKE OATH AND SAY:

1. I have executed the actions required of the Corporation stipulated by the Ontario Energy Board ("OEB") as set out in the Letter of Direction ("LoD") issued by the OEB to TESI on January 10, 2020, which includes that the below actions be completed prior to January 29, 2020, which is the publication date of the newspaper in which the Revised Notice will appear last:

"You are directed:

1. To conduct a search of title forthwith sufficient to identify the current registered property owners, those who hold encumbrances on the lands, and those with any interest in the lands directly affected by the application;

2. To arrange for the service of the enclosed Revised Notice, in the exact form accompanying this letter and the application and the evidence, directly on each of the following:

- a) All registered intervenors in EB-2011-0076/FB-2011-0077/EB-2011-0078*
- b) All property owners and encumbrancers with lands or interest in lands identified in the search of title referred to in paragraph 1 above*
- c) operators of rail lines, telecommunications or other utilities along or crossing the routes of the affected area*
- d) the Clerks of the Township of Stanley, the Municipality of Bluewater and the County of Huron*
- e) The Métis Nations of Ontario, Lands, Resources and Consultation Office, 66 Slater Street, Suite 1100, Ottawa Ontario K1P 5H1*
- f) The Petroleum Resources Center of the Ministry of Natural Resources and Forestry*

(Note: It is acceptable to serve a party with an electronic copy of the evidence, provided the party has stated its preference for the same.)

3. To make a copy of the Revised Notice, the application and evidence, and any amendments thereto, available for public review at TESI's office and in a prominent place on TESI's website."

2. I engaged legal counsel, being Mr. Paul J Hendriks, Barrister and Solicitor, with his principle place of business located at 243 Parkhill Main Street, Parkhill, Ontario, N0M 2K0, on January 15, 2020, in order to conduct a Title Search sufficient to identify (i) the current registered property owners, those

who hold encumbrances on the lands, and those with any interest in the lands directly affected by TESI's Application, and (ii) operators of rail lines, telecommunications or other utilities along or crossing the routes of the affected area. The complete list of Property Identification Numbers ("PINs") is appended hereto as Schedule A.

3. I have identified any and all registered intervenors from OEB file numbers EB-2011-0076, EB-2011-0077, and EB-2011-0078 by reviewing and recording all registered intervenors as they appear on the OEB's website archive.
4. I have identified and confirmed the mailing addresses for the Métis Nations of Ontario, Lands, Resources, and Consultations Office.
5. I have identified and confirmed the mailing addresses for (i) the Clerk and Chief Administrative Officer ("CAO") for Huron County, and (ii) the CAO for the Municipality of Bluewater. Please note, the Township of Stanley has been amalgamated into the Municipality of Bluewater, and thus the distinction between the OEB LoD and the municipal entities served. Further, no address could be located distinctly for a Clerk in the Municipality of Bluewater, and thus the Notice has been mailed to the Attention of the CAO thereof.
6. I have identified and confirmed the mailing address for the Petroleum Operations Section of the Ministry of Natural Resources and Forestry ("MNRF"). Please note, the LoD identified this MNRF unit as the *Petroleum Resources Center*, however, upon speaking with a staff employee at the MNRF, they confirmed that the closest known unit serving this function for the MNRF is the *Petroleum Operations Section*, for which I communicated this with the OEB via email on January 23, 2020.
7. I have served via regular mail a total of 47 Notices to the 47 identified recipients, 46 of which were mailed on January 24, 2020 at the Canada Post Office located at 9926 Keele St, Vaughan, ON L6A 1S3, at approximately 2:30pm, with the remaining one notice mailed on January 27, 2020 at the Canada Post Office located at 1938 Bloor St W, Toronto, ON M6P 3K8, at approximately 2:30pm. All of the Notice packages contained the (i) OEB Notice, (ii) TESI Application, and (iii) accompanying evidence, and nothing more. Where more than one address was provided for the same named recipient, packages were mailed to both or all addresses. A Master List of all identified recipients who received mail is appended hereto as Schedule B. Scanned copies of all the mailed packages is appended hereto as Schedule C.
8. I have made a copy of the Revised OEB Notice, and the Application and accompanying evidence available at TESI's new address of 100 Arisaig Drive, Vaughan, Ontario, Canada, L6A 1V7, on January 23, 2020, as directed by the OEB LoD. However, TESI does not have a company website, and thus it is not possible to have posted the above materials in a prominent place thereon.
