SYNERGY NORTH CORPORATION

Final Rate Order for rates and other charges effective May 1, 2020 and implemented November 1, 2020

INTRODUCTION AND SUMMARY

In its Decision and Rate Order in this proceeding, issued April 16, 2020, the Ontario Energy Board (OEB) approved new electricity distribution rates for Synergy North Corporation (Synergy North), with an effective date of May 1, 2020. In consideration of the COVID-19 emergency, the Decision and Rate Order also granted Synergy North the option to postpone implementation of its new rates, and to track temporarily forgone revenue in a deferral and variance account.

Synergy North Corporation operates two rate zones: the Thunder Bay Hydro rate zone, representing the legacy service territory of the former Thunder Bay Hydro Electric Distribution Inc., and the Kenora Hydro rate zone, representing the legacy service territory of the former Kenora Hydro Electric Corporation Limited. As noted in the decision, the distributor will continue to operate the two rate zones until such time as rates are rebased.

Through this Final Rate Order, the OEB authorizes Synergy North to implement its new rates on November 1, 2020 for each of its rate zones.

As a result of the OEB's findings in this order, there will be a monthly total bill increase of \$1.30 before taxes and the Ontario Electricity Rebate (OER) for a residential customer in the Thunder Bay Hydro rate zone consuming 750 kWh, effective November 1, 2020. For a residential customer in the Kenora Hydro rate zone consuming 750 kWh, there will be a monthly total bill increase of \$0.53 before taxes and the OER, effective November 1, 2020.

THE PROCESS

Synergy North filed an Incentive Rate-setting Mechanism (IRM) application with the OEB on October 28, 2019, seeking approval for changes to its electricity distribution rates.

On April 16, 2020, the OEB issued its Decision and Order approving Synergy North's new rates for each rate zone, with an effective date of May 1, 2020. However, in light of the uncertainty regarding the severity and duration of the COVID-19 emergency, the Decision and Order also granted Synergy North the option to postpone implementation of its new rates and to track temporarily forgone revenue in Account 1509, Impacts Arising from the COVID-19 Emergency, Sub-account Lost Revenues.

On April 23, 2020, Synergy North filed a letter with the OEB, advising that the utility had elected to postpone the implementation of its new rates.

Synergy North requested that the revised microFIT charge of \$4.55 be implemented on May 1, 2020.

The OEB issued a Vary Order in this proceeding on April 28, 2020 to implement the revised microFIT charge and to postpone implementation of its remaining new rates to November 1, 2020.

On April 17, 2020, the OEB issued [initial implementation guidance](#) to all distributors who had been authorized to postpone implementation of their 2020 rates. The OEB advised that distribution revenue associated with the postponement of the implementation should be tracked separately, by customer class, within Account 1509 - Impacts Arising from the COVID-19 Emergency, Sub-account Lost Revenues, and may include the following components, as applicable:

- impacts arising from the postponement of changes to monthly fixed service charges and variable distribution charges
- forgone distribution revenue due to the postponement of the implementation of an approved Incremental Capital Module
- impacts arising from the postponement of the change in the microFIT monthly fixed service charge

On August 6, 2020, the OEB issued an [Accounting Order](#), a COVID-19 Forgone Revenue Rate Rider Model, and associated filing instructions and account guidance for those utilities that wished to seek recovery of forgone revenue, the implementation of their 2020 rate increase, or both. In the Accounting Order, the OEB established a new sub-account under the Impacts Arising from the COVID-19 Emergency Account, called

the Forgone Revenues from Postponing Rate Implementation sub-Account. The OEB advised that this new sub-account was to be used to record forgone revenues due to the postponement of rate implementation as a result of the COVID-19 emergency. The OEB further explained that any utility that had already recorded forgone revenue amounts due to postponing rate implementation in the Lost Revenues sub-account was to transfer these amounts to the Forgone Revenues from Postponing Rate Implementation sub-account.

The OEB required utilities that wished to seek recovery of forgone revenue, the increase to their 2020 base rates or both, to provide their calculations for the forgone revenue rate rider (if applicable), and tariff of rates and charges as part of the COVID-19 Forgone Revenue Rate Rider model by September 15, 2020.

COVID-19 FORGONE REVENUE RECOVERY

Synergy North filed its COVID-19 Forgone Revenue Rate Rider Model with the OEB on September 15, 2020.

Together with the model, Synergy North filed a letter requesting that the OEB confirm Synergy North's authorization to implement its approved May 1, 2020 distribution rates and Retail Transmission Service Rates (RTSRs) on November 1, 2020 as well as the implementation of its 2020 Group 1 Deferral and Variance Account and Global Adjustment rate riders as of November 1, 2020 through October 31, 2021.

Synergy North also requested to defer the recovery of any forgone revenue resulting from the six-month postponement of the implementation of its 2020 distribution rates. Synergy North proposed to maintain the forgone revenue sub-account balances for a future disposition request (either as part of its 2021 IRM rate application or, a subsequent rate proceeding, or at the latest, as part of its next rebasing application). Synergy North cited the current economic climate and continuous uncertainty related to COVID-19 as rationale to defer collection of any forgone revenue.

FINDINGS

The OEB has reviewed Synergy North's request for implementation of 2020 distribution rates as well as the revised Tariff of Rates and Charges and is satisfied that they accurately reflect the Decision and Rate Order issued on April 16, 2020 and the Vary Order issued on April 28, 2020.

THE ONTARIO ENERGY BOARD ORDERS THAT:

1. The Tariff of Rates and Charges set out in Schedule A of this Final Rate Order is approved effective May 1, 2020 and is to be implemented November 1, 2020. The Tariff of Rates and Charges will apply to electricity consumed, or estimated to have been consumed, on and after November 1, 2020. Synergy North Corporation shall notify its customers of the rate changes no later than the delivery of the first bill reflecting the new rates.
