**Application for rates and other charges for the Orillia Power
and Peterborough Distribution service territories to be
effective January 1, 2022**

1 OVERVIEW

The Ontario Energy Board (OEB) is approving changes to the rates that Hydro One Networks Inc. (Hydro One) charges to distribute electricity to its customers, effective January 1, 2022.

As a result of this Decision, there will be a monthly total bill decrease of \$6.20 in the service territory formerly served by Orillia Power Distribution Corporation (Orillia Power), and a monthly total bill increase of \$1.66 in the service territory formerly service by Peterborough Distribution Inc. (Peterborough Distribution), for a residential customer consuming 750 kWh, effective January 1, 2022. These changes do not factor in applicable taxes or the Ontario Electricity Rebate.

2 CONTEXT AND PROCESS

Hydro One filed its application on August 27, 2021 under section 78 of the *Ontario Energy Board Act, 1998* and in accordance with Chapter 3 of the OEB's *Filing Requirements for Incentive Rate-Setting Applications*.

On April 30, 2020, the OEB issued Decisions and Orders approving the Mergers, Amalgamations, Acquisitions and Divestitures (MAADs) applications previously filed by Hydro One's parent company, Hydro One Inc.¹ Hydro One Inc. received approvals to purchase all of the issued and outstanding shares of Orillia Power and to purchase the distribution system of the amalgamated corporation of Peterborough Distribution and Peterborough Utilities Services Inc., and to subsequently transfer the assets and liabilities of the electricity businesses to Hydro One.

As part of Hydro One's MAADs applications for Orillia Power and Peterborough Distribution, the OEB, in each application, approved Hydro One's proposal to defer the rebasing of the consolidated entities for a ten-year period. During years one to five of the deferred rebasing period, all base distribution delivery rates for the acquired customers of Orillia Power and Peterborough Distribution are frozen. In addition, there is a 1% reduction in base distribution delivery rates for residential, general service and large use customers.

The OEB follows a standardized and streamlined process for hearing incentive rate-setting mechanism (IRM) applications. In each adjustment year of an IRM term, the OEB prepares a Rate Generator Model that includes, as a placeholder, information from the distributor's past proceedings and annual reporting requirements. The distributor then reviews, completes, and includes the model with its application, and may update the model during the proceeding to make any necessary corrections or to incorporate new rate-setting parameters as they become available.

The legacy Orillia Power service area consists of approximately 14,000 mostly residential and commercial customers in the City of Orillia. The legacy Peterborough Distribution service area consists of approximately 37,000 mostly residential and commercial customers in the City of Peterborough, the Town of Norwood and the Village of Lakefield.

Notice of the application was issued on September 13, 2021. Power Workers' Union (PWU) requested intervenor status. The OEB approved PWU as an intervenor. The OEB made no provision for cost awards in this proceeding.

The application was supported by pre-filed written evidence and a completed Rate Generator Model. Hydro One updated and clarified the evidence during the proceeding.

Hydro One responded to interrogatories from OEB staff. Final submissions on the application were filed by OEB staff and Hydro One filed a reply.

3 DECISION OUTLINE

Each of the following issues is addressed in this Decision, together with the OEB's findings.

- Retail Transmission Service Rates
- Deferral and Variance Accounts

Instructions for implementing Hydro One's new rates and charges are set out in the final section of this Decision.

This Decision does not address rates and charges approved by the OEB in prior proceedings, such as specific service charges² and loss factors, which are out of scope in an IRM proceeding and for which no further approvals are required to continue to include them on the distributor's Tariff of Rates and Charges. There is no annual adjustment as rates are frozen for five years per the MAADs decision.

4 RETAIL TRANSMISSION SERVICE RATES

The service area formerly served by Orillia Power is fully embedded within Hydro One Networks Inc.'s distribution system and Peterborough Distribution is partially embedded within Hydro One Networks Inc.'s distribution system.

To recover its cost of transmission services, Hydro One requests approval to adjust the retail transmission service rates (RTSRs) that it charges its customers in accordance with the Uniform Transmission Rates (UTRs) and host distributor RTSRs currently in effect.

Findings

Hydro One's proposed adjustment to its RTSRs is approved. The RTSRs were adjusted based on the current OEB-approved UTRs and host-RTSRs.³

UTRs and host-RTSRs are typically approved annually by the OEB. In the event that new UTRs or host-RTSRs take effect during Hydro One's 2022 rate year, any resulting differences (from the prior-approved UTRs and host-RTSRs) are to be captured in Retail Settlement Variance Accounts 1584 (Retail Transmission Network Charge) and 1586 (Retail Transmission Connection Charge).

5 DEFERRAL AND VARIANCE ACCOUNTS

Group 1 Deferral and Variance Accounts

In each year of an IRM term, the OEB will review a distributor's Group 1 deferral and variance accounts to determine whether those balances should be disposed. OEB policy states that Group 1 account balances should be disposed if they exceed, on a net basis (as a debit or credit), a pre-set disposition threshold of \$0.001 per kWh, unless a distributor can justify why balances should not be disposed.⁴ If the balance does not exceed the threshold, a distributor may still request disposition.

The 2020 year-end net balance for the Orillia Power rate zone's Group 1 accounts that are eligible for disposition, including interest projected to December 31, 2021, is a debit balance of \$1,813,130, and pertains to variances accumulated during the 2017 to 2020 calendar years. The 2020 year-end net balance for the Peterborough Distribution rate zone Group 1 accounts that are eligible for disposition, including interest projected to December 31, 2021, is a debit balance of \$2,066,556, and pertains to variances accumulated during the 2017 to 2020 calendar years. Hydro One seeks relief from the requirement to dispose Group 1 accounts in the 2022 rate year for the following reasons⁵:

- i) Customer data is required for the rate rider calculations, which was in the process of being transferred to Hydro One's systems, and
- ii) The Peterborough Distribution rate zone's Group 1 balances remain subject to an audit. In the decision and rate order for 2019 rates for Peterborough Distribution, the OEB noted concerns with the volume and quantum of adjustments to the Account 1588 – RSVA Power and Account 1589 – RSVA GA balances during the course of that proceeding.⁶ The OEB found that an audit of the December 31, 2017 Accounts 1588 and 1589 balances was necessary.⁷ Hydro One also indicated that it will further review the balances prior to requesting disposition.

Findings

The OEB accepts Hydro One's proposal to defer disposition of its Group 1 accounts for the service areas formerly served by Orillia Power and Peterborough Distribution. The OEB notes and accepts that the deferral is due to the transfer of customer data that is

still pending integration into Hydro One's system for both rate zones as well as a pending audit for the Peterborough Distribution rate zone.

Group 2 Deferral and Variance Accounts

Orillia Power Rate Zone's Account 1575 and Account 1576

Hydro One proposed to dispose a debit balance of \$14,305 for Account 1575 and a credit balance of \$4,140,935 for Account 1576 for the Orillia Power rate zone, over a two-year period, in accordance with the direction provided in the related MAADs decision.⁸

The Account 1575 and 1576 balances include a return component applied to the principal balance, based on the OEB's 2022 WACC of 5.47%. Hydro One stated that it applied the OEB's 2022 weighted average cost of capital (WACC), consistent with the OEB's decision to apply the OEB's 2021 WACC on Newmarket-Tay Power Distribution Inc.'s (Newmarket-Tay Power) Account 1576 related base rate adjustment.^{9,10} Hydro One further explained that in that decision, the OEB noted that the 2021 WACC parameters were applicable, as the adjustment will apply to rates going forward.

OEB staff submitted that the appropriate WACC to apply to Account 1575 and 1576 balances is the WACC approved in the distributor's last cost of service proceeding, which would be 7.49% instead of the OEB's 2022 WACC of 5.47% for the Orillia rate zone.¹¹ OEB staff referenced previously approved dispositions of Account 1576, in which the last approved WACC was applied to Account 1576. OEB staff further noted at issue in this proceeding is the WACC applied to the Account 1576 balance; and that in the Newmarket-Tay Power proceeding Hydro One referenced, the OEB only approved the OEB's 2021 WACC to be applied to the base rate adjustment. In that proceeding, the OEB applied the last approved WACC on the Account 1576 balance. In its reply submission, Hydro One did not take issue with OEB staff's submission and updated the Account 1575 balance to a credit balance of \$15,595 and the Account 1576 balance to a credit balance of \$4,343,161, reflecting return component using a 7.49% WACC.

Findings

The OEB approves a 2-year disposition of Orillia Power's Account 1575 and Account 1576 balances and finds that a WACC of 7.49% is to be applied. The OEB agrees with OEB staff's submission as did Hydro One in its reply submission that a WACC of 7.49%

is appropriate. The OEB's rationale for applying a WACC of 7.49% is because of the consistency of this with:

- the last approved WACC in effect when the variance occurred, and
- with the OEB's decision approving the interim disposition of Orillia Power rate zone's 2014 Account 1576 balance in which the last approved WACC was also applied to Account 1576.

Peterborough Distribution Rate Zone's Account 1575

Hydro One initially requested to dispose of a debit balance of \$9,998 in Account 1575 for the Peterborough Distribution rate zone, which represents a residual balance remaining from a previously approved disposition of that account. In response to interrogatories, Hydro One noted that the related OEB MAADs decision states that it is appropriate to dispose of the Orillia Power and Peterborough Distribution rate zones' balances in Accounts 1575 and 1576 within twelve months of the closing of the transaction. However, Hydro One removed its disposition request for Peterborough rate zone's residual Account 1575 balance as the amount is not material, and this approach would be consistent with the approach taken in the 2022 rates proceeding for Hydro One's other acquired entities (Norfolk, Haldimand, Woodstock).¹²

OEB staff submitted that Hydro One's removal of the Account 1575 balance for disposition is appropriate, as the OEB has not provided guidance that indicates residual Account 1575 balances are to be requested for disposition and has not historically disposed of residual balances for this account.

Findings

The OEB approves Hydro One's request for removal of the disposition of the Account 1575 balance. The OEB agrees with OEB staff that the removal of the Peterborough Distribution Account 1575 debit balance does not contradict the MADDs decision and that it is consistent with OEB past practice with this account which has not required tracking of residual amounts once the original balance was disposed. Lastly, the amount is immaterial.

Other Group 2 Accounts

The 2020 Group 2 balances (excluding Account 1575 - IFRS-CGAAP Transitional PP&E Amounts and Account 1576 - Accounting Changes Under CGAAP) for the Orillia Power and Peterborough Distribution rate zones total a debit amount of \$773,709 and a debit amount of \$541,431, respectively.¹³ Hydro One indicated that it plans to request disposition of these Group 2 accounts at its next rebasing application. Hydro One further stated that if the balances become material before the next rebasing proceeding, it will propose disposition at the relevant annual update.¹⁴

In its submission, OEB staff noted that some of the Group 2 balances for the Orillia Power and Peterborough Distribution rate zones started accumulating in 2009 and 2012, respectively, and there may be intergenerational equity issues if certain Group 2 account balances are allowed to accumulate over an approximate twenty-year period before disposition at the next rebasing application. OEB staff submitted that Hydro One may consider bringing forth the Group 2 balances that have accumulated for an extended period, for review and potential disposition in its next annual rate application (for these rate zones), similar to what it has done with Accounts 1575 and 1576 in this proceeding. Hydro One stated that it did not take issue with OEB staff's submission and will consider bringing forth the Group 2 balances for review and potential disposition as part of its next annual rate application.

Findings

The OEB orders Hydro One to bring forward the Group 2 DVA balances for disposition in the next rate proceeding for Orillia Power and Peterborough Distribution, respectively. The OEB shares OEB staff's concern with the intergenerational equity issues associated with waiting until the end of the 10-year rebasing term to expire for Orillia and Peterborough's rate zones on July 31, 2030 and August 31, 2030, respectively.

6 IMPLEMENTATION

This Decision is accompanied by Rate Generator Models, applicable supporting models, and Tariffs of Rates and Charges (Schedule A). The Rate Generator Model also incorporates the rates set out in Table 6.1.

Table 6.1: Regulatory Charges

Rate	per kWh
Rural or Remote Electricity Rate Protection (RRRP)	\$0.0005
Wholesale Market Service (WMS) billed to Class A and B Customers	\$0.0030
Capacity Based Recovery (CBR) billed to Class B Customers	\$0.0004

Each of these rates is a component of the “Regulatory Charge” on a customer’s bill, established annually by the OEB through a separate, generic order. The RRRP, WMS and CBR rates were set by the OEB on December 10, 2020.¹⁵

The Smart Metering Entity Charge is a component of the “Distribution Charge” on a customer’s bill, established by the OEB through a separate order. The Smart Metering Entity Charge was set by the OEB on March 1, 2018.¹⁶

In the *Report of the Board: Review of Electricity Distribution Cost Allocation Policy*,¹⁷ the OEB indicated that it will review the default province-wide microFIT charge annually to ensure it continues to reflect actual costs in accordance with the established methodology. Distributors shall apply the updated value, if applicable, following the OEB’s announcement of the microFIT charge for the 2022 rate year.

7 ORDER

THE ONTARIO ENERGY BOARD ORDERS THAT:

1. Hydro One Networks Inc.'s new final distribution rates shall be effective January 1, 2022, in accordance with the Tariff of Rates and Charges set out in Schedule A.
2. The Tariff of Rates and Charges are deemed draft until Hydro One Networks Inc. has complied with the subsequent procedural steps.
3. Hydro One Networks Inc. shall review the Tariff of Rates and Charges and shall file with the OEB, as applicable, a written confirmation of its completeness and accuracy, or provide a detailed explanation of any inaccuracies or missing information, by **December 21, 2021**.
4. This Decision and Rate Order will be considered a final rate order if Hydro One Networks Inc. does not provide a submission to the OEB that inaccuracies were found or information was missing pursuant to item 3.
5. If the OEB receives a submission from Hydro One Networks Inc. to the effect that inaccuracies were found or information was missing pursuant to item 3, the OEB will consider the submission prior to issuing a final rate order.
6. Hydro One Networks Inc. shall notify its customers of the rate changes no later than the delivery of the first bill reflecting the new rates.

RESIDENTIAL SERVICE CLASSIFICATION

Residential class customers are defined as single-family dwelling units for domestic or household purposes. Semi-detached and row town-housing will be considered residential class if each individual unit is located on its own registered freehold lot fronting on the public road allowance. Each unit must have its own individual service connection from the road allowance and each main service disconnect is assessable from the unit which it supplies. All other developments are considered to be in the General Service class. Further servicing details are available in the distributor's Conditions of Service.

GENERAL SERVICE 50 TO 4,999 KW SERVICE CLASSIFICATION

This classification applies to all buildings not classified as residential and having a service connection capable of load delivery equal to or above 50 kW or having an average monthly peak demand equal to or greater than 50 kW over a twelve month period, but less than 5,000 kW. A customer must remain in its customer class for a minimum of twelve (12) months before being reassigned to another class. Customers who require service connections above 1,000 kVA must supply and own the primary conductors, switchgear and their own transformation above the maximum supplied by 1937680 Ontario Inc. (see Section 3.3 of Conditions of Service). The maximum allowable service connection on the 27.6 kV system is 5,000 kVA. Customers have the option of ownership of transformation at all sizes and are required to own the transformation above the maximum levels supplied by 1937680 Ontario Inc. If a customer decides or is required to own their transformation, the transformer specifications and its loss evaluation require approval from 1937680 Ontario Inc. The customer is required to compensate 1937680 Ontario Inc. for transformer losses that exceed the maximum acceptable losses. The customer will receive a transformer allowance as specified in the current rate schedule for privately owned transformation.

APPLICATION

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, or as specified herein.

Unless specifically noted, this schedule does not contain any charges for the electricity commodity, be it under the Regulated Price Plan, a contract with a retailer or the wholesale market price, as applicable.
