**RE: EB-2022-0086 – Enbridge Gas Inc. – Dawn to Corunna Replacement Project  
Update on Status of Settlement Negotiations – OEB Procedural Order No. 5**

We are the lawyers for CAEPLA-DCLC in the above noted proceeding. Pursuant to the OEB's Procedural Order No. 5 issued on September 19, 2022, we wrote to the OEB on September 20, 2022 to provide an update on the status of ongoing settlement negotiations between CAEPLA-DCLC and Enbridge Gas Inc. ("Enbridge"). We are pleased to report that as a result of continuing negotiations, CAEPLA-DCLC and Enbridge have reached a settlement in principle regarding CAEPLA-DCLC landowner issues. This settlement is subject to ratification by the full membership of CAEPLA-DCLC. A ratification meeting has been scheduled for Wednesday, September 28, 2022.

In light of the settlement in principle reached by CAEPLA-DCLC and Enbridge, CAEPLA-DCLC did not file written submissions in this proceeding by the September 23, 2022 deadline pursuant the OEB's Procedural Order. CAEPLA-DCLC is hopeful and confident that the settlement in principle reached by CAEPLA-DCLC's Negotiating Committee will be ratified by the membership. However, should it become necessary to do so in the event that the settlement is not ratified, CAEPLA-DCLC proposes to file written submissions by this Friday, September 30, 2022 and Enbridge will file its reply submissions by Thursday, October 6, 2022. If the settlement is ratified, CAEPLA-DCLC and Enbridge will provide a further update to the OEB and the other parties regarding the settlement as soon as possible.
