**Re: Enbridge Gas Inc. 2024 Rebasing Application
Partial Agreement on the Draft Issues List
OEB File No. EB-2022-0200**

Pursuant to Procedural Order No. 1, dated December 16, 2022, an issues list conference was held on January 9, 2023 to consider the draft issues list, the assignment of issues to each phase of the proceeding, as well as the timing to consider Phase 2 issues.

On behalf of Enbridge Gas and the intervenors, OEB staff is filing a marked-up copy of the draft issues list that reflects the issues for which there is agreement and the issues that are disputed. Where there is no comment, or mark-up, on an individual issue, parties agree that the issue, as set out in Schedule B to Procedural Order No. 1, should be reflected, without change, in the final issues list.

OEB staff notes that Enbridge Gas and the intervenors agreed to a number of issues, and the phasing for hearing those issues, that they believe should be reflected in the final issues list for this proceeding. However, there are two storage-related issues that are disputed, and OEB staff will also be commenting on proposed issue #59 in submissions, which are due on January 16, 2023.¹

OEB staff advises that parties agreed that, given that the issues list was prepared prior to the interrogatory process, parties may wish to raise additional matters for inclusion on the issues list after the responses to the interrogatories are received.

¹ Proposed Issue #59 states: Should the OEB Commissioners make a recommendation, as proposed, to the Chief Executive Officer of the OEB for a review of GDAR's SQR measures based on customer experience and expectations, and current industry and technical standards?
