**Re: Elexicon Energy Inc. (“Elexicon”) Application for 2023 Distribution Rates and Incremental Capital funding (“Application”) Ontario Energy Board (“OEB”) File Number: EB-2022-0024 Redactions of Attachments to SEC-01**

We are counsel to Elexicon in the above-noted Application. On September 29, 2022, the School Energy Coalition (“SEC”) filed the following interrogatory labelled “SEC-01”:

Please provide a copy of all material provided to the Applicant’s Board of Directors regarding the proposed ICM for the Whitby Smart Grid (WSG) project.

On October 18, 2022, Elexicon filed its Responses to the Interrogatories (“IRs”) pursuant to Procedural No. 1. In response to IR SEC-01, Elexicon filed redacted versions of: (a) Attachment 1 – Management’s update to its Board of Directors on June 14, 2022; and (b) Attachment 2 – Management’s September 27, 2022 report to its Board of Directors that included the presentation made to Whitby Town Council (together the “SEC-01 Attachments”).

Elexicon unintentionally filed only redacted versions of the SEC-01 Attachments. This was brought to our attention during technical conference and was an unintentional oversight. We reviewed the *Practice Direction on Confidential Filings* that was amended on December 17, 2021 to include a process for the redaction of non-relevant information.

Elexicon’s view is that the SEC-01 Attachments contain some information that is relevant and other information that is not relevant to SEC’s request in IR SEC-01. Elexicon is filing both a non-confidential, redacted version and a confidential, un-redacted version of the SEC-01 Attachments containing all of the information for which redactions for non-relevance have been made, the specifics of which are outlined in the table below.

Ellexicon respectfully requests that the OEB determine that the redacted information is not relevant and accept the filed non-confidential, redacted versions of the SEC-01 Attachments. We note that pages 10-16 of SEC-01 – Attachment 2 were unintentionally redacted and have been disclosed, however this WSG presentation to Whitby Town Council was already on the record in SEC – 11, Attachment 1.
