# Re: Enabling the Implementation of an Ultra-Low Overnight TOU Price Plan Board File No.: EB-2022-0160

We are counsel to the Electric Vehicle Society (**EVS**) in the above-noted consultation (the **Consultation**). Further to the Board's Notice of Hearing for Cost Awards dated May 9, 2023, please find enclosed EVS's cost claim in respect of the Consultation.

EVS respectfully requests an award of 100% of its eligible costs, given its strategic and principled participation in the Consultation, reflecting the unique interests of otherwise unrepresented enduse distributed energy resource (**DER**) and electric vehicle (**EV**) residential consumers. EVS submits that this request is supported by the following considerations:

- (a) EVS attended and participated effectively in the Consultation on matters related to the enabling the implementation of an Ultra-Low Overnight (**ULO**) TOU price plan and assisted in contributing to the Board's better understanding of such matters;
- (b) EVS ensured that its participation in the Consultation and its comments on the ULO price plan design were focused on relevant and material issues important to the Consultation and the consumers represented by EVS; and
- (c) EVS participated responsibly to avoid overlap, maximize efficiency, and ensure that its participation was not unduly repetitive and was focused on relevant and material issues.

We trust that this approach maximizes the efficient use of resources and the right of otherwise unrepresented and important end-use residential EV consumers to be heard in a manner that is consistent with the Board's mandate and statutory objectives.

EVS respectfully requests a full award of eligible costs.
