## **Issues:**

The Consumers Council of Canada is materially impacted by the application as it represents residential consumers of electricity. UCT 2 is, through this Application, seeking rate recovery and rate treatment of the differences between actual and budgeted construction costs for the East-West Tie Line Project. Those costs will ultimately be paid by electricity consumers. The Council will assess whether the costs UCT 2 is seeking to recover from electricity consumers are reasonable.
