Further to the Ontario Energy Board's (OEB) acknowledgment letter dated May 1, 2024, the OEB has completed its preliminary review of Tillsonburg Hydro's 2024 Cost of Service rate application and notes that Tillsonburg Hydro has not filed certain information, attached Appendix A, which it is required to file under the OEB's [Chapter 2 and 5 Filing Requirements for Electricity Distribution Rate Applications – 2023 Edition for 2024 Rate Applications](#).

The OEB understands that Tillsonburg Hydro is working to meet the OEB's requirements in this regard and has therefore decided to commence its review of Tillsonburg Hydro's application and proceed with its Notice of Hearing. Given that the OEB has commenced its review of Tillsonburg Hydro's application, the OEB requires that Tillsonburg Hydro complete and file the missing items in the attached Appendix A by May 21, 2024. The filing of the information by May 21, 2024, will allow the OEB to continue processing the application in a timely manner. If the noted information is not filed by May 21, 2024, the OEB will stop processing Tillsonburg Hydro's application and place the application in abeyance, until such time the missing information is filed.

Pursuant to Chapter 1 of the [OEB's Filing Requirements For Electricity Distribution Rate Applications - 2022 Edition for 2023 Rate Applications](#), Tillsonburg Hydro has confirmed that the documents it has filed in support of the above referenced application do not
