Public Energy operates natural gas-fired distributed energy resources, connected behind-the-meter, for C&I customers in Ontario. Public Energy has Energy Supply Agreements with its customers.

9. (e) Describe in detail the applicant's current or intended business model and product offering(s). Include details of all products the applicant intends to offer to its customers and explain how the commodity pricing will be determined for each of the applicant's product offering.

Public Energy operates natural gas-fired distributed energy resources, connected behind-the-meter, for C&I customers in Ontario. Public Energy has Energy Supply Agreements with its customers. PE's operations focus on peak shaving or Global Adjustment mitigation, operating for up to 500 hours per year to hit the top 5 peak hours every year. PE has two business models: i) monthly capacity payment; and ii) shared savings. The monthly capacity fee and the % split for shared savings is determined based on contract term, capital expense for the DER installation, and operating costs per year. PE typically provides 10-20% of electricity savings for its customers by mitigating GA under Ontario's ICI program.

Public Energy works with Rodan Energy Services for ancillary services, specifically demand response. Rodan aggregates smaller C&I customers and is able to get competitive prices for demand response for their customers, including Public Energy's multiple sites. Public Energy's obligations will not be impacted using Rodan as Rodan is a market participant in the IESO and must conform to the IESO's legal and regulatory obligations.
