Further to the Ontario Energy Board's (OEB) acknowledgement letter dated August 16, 2024, the OEB has completed its preliminary review of your 2025 Transmission Revenue Requirement application and will now commence the processing of your application. Information and Protection of Privacy Act, unless filed in accordance with rule 9A of the OEB's *Rules of Practice and Procedure*.

Following these steps, the delegated decision maker will provide you with a draft of their proposed decision. You will be given seven days within which to provide comments on the draft decision. The delegated decision maker will then consider your comments, if any, and issue a final decision.
