



Hydro One Sault Ste. Marie Limited Partnership

Application for electricity transmission rates effective January 1, 2025

PROCEDURAL ORDER NO. 1 August 30, 2024

Hydro One Sault Ste. Marie Limited Partnership (HOSSM) filed an application with the Ontario Energy Board (OEB) on July 19, 2024, under section 78 of the *Ontario Energy Board Act*, *1998*, seeking approval of its annual revenue requirement for electricity transmission, effective January 1, 2025, and inclusion of its approved revenue requirement in the Uniform Transmission Rates. HOSSM is also seeking to dispose of the balance of its Earnings Sharing Mechanism (ESM) account as of December 31, 2023.

A Notice of Hearing was issued on August 12, 2024. The OEB did not receive any intervention requests.

At this time, the OEB is making provision for the filing of written interrogatories, responses to interrogatories and written submissions. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

- 1. OEB staff shall request any relevant information and documentation from HOSSM that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on HOSSM, by **September 6, 2024**.
- 2. HOSSM shall file with the OEB complete written responses to the interrogatories by **September 20, 2024**.
- 3. Any written submissions by OEB staff shall be filed with the OEB and served on HOSSM by **October 2, 2024**.
- Any reply submissions by HOSSM, shall be filed with the OEB by October 15, 2024.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's <u>Rules of Practice and Procedure</u>.
