

**OEB Staff Question - 1**

**Ref: 2025 IRM Rate Generator Model update review**

**Question:** Please review the updated Kingston Hydro 2025 IRM Rate Generator model received on November 5, 2024 to review and confirm the accuracy of the updates based on changes to the RPP, Ontario Electricity Rebate, and UTR.

**Kingston Hydro Response Staff Question 1:** Kingston Hydro has reviewed the 2025 IRM Application EB-2024-0037 updated live Excel model received on November 5, 2024. Kingston Hydro has completed an update on *Tab 11 RTSR – UTRs & Sub-Tx* relating to the Hydro One Sub-Transmission Rate Network Service Rate value noted for 2025 in Column L, Row 35. This value has been updated to 5.2172. Kingston Hydro can confirm the accuracy of the updates and the model. The updates include the changes to the Regulated Price Plan (RPP), Ontario Electricity Rebate (OER), Uniform Transmission Rates (UTR) and the Retail Transmission Service Rates (RTSR). The updates to the RPP and OER reflect the OEB and Ontario Government updates that came into effect on November 1, 2024<sup>1</sup>. The UTR and RTSR changes reflect the updated rates from the 2025 Preliminary Uniform Transmission rates and Hydro One Sub-Transmission Rates EB-2024-0244 notice issued on November 1, 2024<sup>2</sup>.
