**Re: Tillsonburg Hydro Inc.
Ontario Energy Board File Number: EB-2023-0053
Errata for November 12, 2024 Decision and Rate Order**

Schedule A to the Decision and Rate Order issued on November 12, 2024 in this proceeding contained a Tariff of Rates and Charges (referred to below as the Tariff).

In its letter dated November 13, 2024, Tillsonburg Hydro notified the Ontario Energy Board (OEB) that it had identified a clerical error in the Tariff. The Tariff incorrectly named one rate class as *General Service 1,500 to 4,999 KW*.

Tillsonburg Hydro requested that the name of this rate class on the Tariff be corrected to *General Service Equal to or Greater than 1,500 KW* to be consistent with Tillsonburg Hydro's approved Decision and Rate Order from its 2023 rates application¹ because no changes were proposed to Tillsonburg Hydro's customer classes in the current application.

In addition to this correction, the OEB has also identified errors in rate riders on the Tariff, and is subsequently making typographical corrections to the following rate riders to reconcile the rate riders in the Tariff with those in the Deferral and Variance Account (DVA) Model filed by Tillsonburg Hydro on October 18, 2024 and included in the settlement proposal:

- General Service <50 kW: Rate Rider for Disposition of Group 1 Deferral/Variance Accounts on the Tariff issued on November 12, 2024 included the amount

\$0.0020/kWh, which is being amended to reflect the correct amount of \$0.0021/kWh.

- General Service 500 to 1,499 kW: Rate Rider for Disposition of Group 1 Deferral/Variance Accounts on the Tariff issued on November 12, 2024 included the amount \$0.7123/kWh, which is being amended to reflect the correct amount of \$0.7390/kWh.
- Unmetered Scattered Load: Rate Rider for Disposition of Group 1 Deferral/Variance Accounts on the Tariff issued on November 12, 2024 included the amount \$0.0021/kWh, which is being amended to reflect the correct amount of \$0.0022/kWh.
- Furthermore, the OEB is amended the name of a Group 2 DVA for the Streetlighting class for greater clarity as follows: Street Lighting: Current rate rider for Group 2 DVAs in the Tariff issued on November 12, 2024 is listed as: "Rate Rider for Disposition of Deferral/Variance Accounts - effective until October 31, 2026"; which is being amended to "Rate Rider for Disposition of Group 2 Deferral/Variance Accounts - effective until October 31, 2026" to match the other rate classes.

Pursuant to its powers under Rule 41.02 of the OEB's *Rules of Practice and Procedure*, the OEB may at any time, without notice or a hearing of any kind, correct a typographical error, error of calculation or similar error made in its orders or decisions.

The OEB has amended its Decision and Rate Order, attaching a corrected Tariff. The only changes in the corrected Tariff are to (a) the name of the one rate class, and (b) the three rate rider amounts and one rate rider name outlined above.

The revised Decision and Rate Order is attached. This revised Decision and Rate Order supersedes and replaces the previously issued Decision and Rate Order. The revised Decision and Rate Order does not change the OEB's findings, nor any of the dates in the previous Decision and Rate Order.
