- 3. To arrange for service of the enclosed English and French versions of the Notices on customers for whom Greater Sudbury Hydro has an email address and the appropriate permissions to use the email address to send utility or regulatory information, together with the following email message:

"Greater Sudbury Hydro Inc. has applied to the Ontario Energy Board to change our electricity distribution rates. Please review the Ontario Energy Board's Notice of Hearing to learn more and to find out how you can participate in the Ontario Energy Board's hearing."
