

1. OVERVIEW

The Ontario Energy Board (OEB) is approving changes to the rates that North Bay Hydro Distribution Limited (North Bay Hydro) charges to distribute electricity to its customers, effective May 1, 2025.

North Bay Hydro continues to maintain two separate rate zones for its legacy utilities¹, referred to as the North Bay Rate Zone and the Espanola Rate Zone.

As a result of this Decision and Rate Order, there will be a monthly total bill increase for a residential customer with a monthly consumption of 750 kWh of:

- \$3.06 for the North Bay Rate Zone
- \$0.49 for the Espanola Rate Zone

This change does not factor in applicable taxes or the Ontario Electricity Rebate.

The OEB is also approving North Bay Hydro's request to change the composition of its distribution service rates for the Espanola Rate Zone. Residential distribution service rates have historically included a fixed monthly charge and a variable usage charge. In 2015, the OEB issued a policy to transition these rates to a fully fixed rate structure over a four-year period beginning in 2016.² North Bay Hydro, however, required a transition period of greater than four years, which was approved by the OEB. This is the fifth, and final year, of North Bay Hydro's transition to fully fixed rates for residential customers in the Espanola Rate Zone. There is no longer a variable usage rate for this class of customers. This change does not affect the total revenue that North Bay Hydro collects from its residential customers.

2. CONTEXT AND PROCESS

North Bay Hydro filed its application on October 30, 2024, under section 78 of the *Ontario Energy Board Act, 1998* and in accordance with [Chapter 3 \(Incentive Rate-Setting Applications\)](#) of the OEB's *Filing Requirements for Electricity Distribution Rate Applications* (Filing Requirements). The application for both rate zones was based on the Price Cap Incentive Rate-setting (Price Cap IR) option, with a five-year term.

The Price Cap IR option is one of three incentive rate-setting mechanisms (IRM) used by the OEB.³ It involves the setting of rates through a cost-of-service application in the first year and mechanistic price cap adjustments which may be approved through IRM applications in each of the ensuing adjustment years.

The OEB follows a standardized and streamlined process for processing IRM applications filed under Price Cap IR. In each adjustment year of a Price Cap IR term, the OEB prepares a Rate Generator Model that includes, as a placeholder, information from the distributor's past proceedings and annual reporting requirements. A distributor then reviews, completes, and includes the model with its application, and may update the model during the proceeding to make any necessary corrections or to incorporate new rate-setting parameters as they become available.

The North Bay Rate Zone serves approximately 24,000 mostly residential and commercial electricity customers in the City of North Bay. The Espanola Rate Zone serves approximately 3,300 mostly residential and commercial electricity customers in the Town of Espanola and the Township of Sables-Spanish Rivers.

The application was supported by pre-filed written evidence and completed Rate Generator Models, and as required during the proceeding, North Bay Hydro updated and clarified evidence for its North Bay Rate Zone and the Espanola Rate Zone.

3. DECISION OUTLINE

Each of the following issues is addressed in this Decision and Rate Order, together with the OEB's findings.

- Annual Adjustment Mechanism
- Retail Transmission Service Rates
- Group 1 Deferral and Variance Accounts
- Residential Rate Design

Instructions for implementing North Bay Hydro's new rates and charges are set out in the final section of this Decision and Rate Order.

This Decision and Rate Order does not address rates and charges approved by the OEB in prior proceedings, such as specific service charges⁴ and loss factors, which are out of the scope of an IRM proceeding and for which no further approvals are required to continue to include them on the distributor's Tariff of Rates and Charges.

4. ANNUAL ADJUSTMENT MECHANISM

North Bay Hydro has applied to change its rates, effective May 1, 2025. The proposed rate change is based on a mechanistic rate adjustment using the OEB-approved **inflation minus X-factor** formula applicable to IRM applications. The adjustment applies to distribution rates (fixed and variable) uniformly across all customer classes.⁵

The components of the Price Cap IR adjustment formula applicable to North Bay Hydro are set out in the table below. Inserting these components into the formula results in a 3.30% increase in North Bay Hydro's rates: **3.30% = 3.60% - (0.00% + 0.30%)**.

An inflation factor of 3.60% applies to all IRM applications for the 2025 rate year. The X-factor is the sum of the productivity factor and the stretch factor. It is a productivity offset that varies among different groupings of distributors. Subtracting the X-factor from inflation ensures that rates decline in real, constant-dollar terms, providing distributors with a tangible incentive to improve efficiency or else experience declining net income. The productivity component of the X-factor is based on industry conditions over a historical study period and applies to all IRM applications for the 2025 rate year. The stretch factor component of the X-factor is one of five stretch factor groupings established by the OEB, ranging from 0.00% to 0.60%. The stretch factor assigned to any distributor is based on the distributor's total cost performance as benchmarked against other distributors in Ontario. The stretch factor assigned to the North Bay Rate Zones as well as the Espanola Rate Zone is 0.30%, resulting in a rate adjustment of 3.30%.

Findings

North Bay Hydro's request for a 3.30% rate increase to both rate zones is in accordance with the annually updated parameters set by the OEB. The adjustment is approved, and North Bay Hydro's new rates in both rate zones shall be effective May 1, 2025.

5. RETAIL TRANSMISSION SERVICE RATES (RTSRs)

In Ontario, some distributors are connected directly to a licensed transmitter, while others may be embedded, or partially embedded, within the distribution system of another licensed distributor. The North Bay Rate Zone is partially embedded in Hydro One Networks Inc.'s (Hydro One) distribution system, while the Espanola Rate Zone is fully embedded within Hydro One's distribution system.

To recover its cost of transmission services for the North Bay Rate Zone, North Bay Hydro requests approval to adjust the RTSRs that it charges its customers in accordance with the Uniform Transmission Rates (UTRs) and host distributor RTSRs currently in effect. For the Espanola Rate Zone, North Bay Hydro requests approval to adjust its RTSRs by the host distributor's RTSR only.

Findings

North Bay Hydro's proposed adjustment to its RTSRs for the North Bay Rate Zone and Espanola Rate Zone is approved.

The RTSRs have been adjusted based on the current OEB-approved UTRs and host RTSRs.

UTRs⁹ and host-RTSRs¹⁰ are typically approved annually by the OEB. In the event that the OEB updates the approved host-RTSRs during North Bay Hydro's 2025 rate year, any resulting differences (from the prior-approved host-RTSRs) will be captured in Retail Settlement Variance Accounts 1584 (Retail Transmission Network Charge) and 1586 (Retail Transmission Connection Charge).

6. GROUP 1 DEFERRAL AND VARIANCE ACCOUNTS

In each year of an IRM term, the OEB will review a distributor's Group 1 deferral and variance accounts (DVAs) to determine whether those balances should be disposed of. OEB policy states that Group 1 account balances should be disposed of if they exceed, on a net basis (as a debit or credit), a pre-set disposition threshold of \$0.001 per kWh, unless a distributor can justify why balances should not be disposed of.¹¹ If the net balance does not exceed the threshold, a distributor may still request disposition.¹²

6.1 North Bay Rate Zone

The 2023 year-end net balance for North Bay Rate Zone's Group 1 accounts eligible for disposition, including interest projected to April 30, 2025, is a debit of \$334,831 and pertains to variances accumulated during the 2023 calendar year. This amount represents a total claim of \$0.0007 per kWh, which does not exceed the disposition threshold.

North Bay Hydro has not requested the disposition of the North Bay Rate Zone's Group 1 DVA balances since the threshold value did not meet the materiality threshold.

6.2 Espanola Rate Zone

The 2023 year-end net balance for Espanola Rate Zone's Group 1 accounts eligible for disposition, including interest projected to April 30, 2025, is a debit of \$865,340. The balance reflects an accumulation of activities from the 2023 calendar year; however, the Global Adjustment and Power variances span from 2021 to 2023. This amount represents a total claim of \$0.0158 per kWh, which exceeds the disposition threshold.

North Bay Hydro has not requested the disposition of the Espanola Rate Zone's Group 1 DVA balances due to the ongoing detailed review and reconciliation of Accounts 1588 and 1589.

Findings

The Group 1 account balances for the North Bay Rate Zone and Espanola Rate Zone appear reasonable, and the threshold calculation is correct. The OEB finds that no disposition is required at this time, as the disposition threshold has not been exceeded and the distributor did not request disposition.

7. RESIDENTIAL RATE DESIGN

Some residential distribution rates currently include a fixed monthly charge and a variable usage charge. The OEB's residential rate design policy stipulates that distributors will transition residential customers to a fully fixed monthly distribution service charge over a four-year period, that began in 2016.¹³ Distributors such as North Bay Hydro, who were approved for a transition period that is greater than four years, or who commenced transition in a later year, are required to continue with this transition until the monthly service charge is fully fixed.

The Espanola Rate Zone deferred filing rate applications for five years from 2016 to 2021. As a result, the Espanola Rate Zone began the transition to fully fixed rates for residential customers on May 1, 2021. This is the fifth year of the transition period.

The OEB expects a distributor to apply two tests to evaluate whether mitigation of bill impacts for customers is required during the transition period. Mitigation usually takes the form of a lengthening of the transition period. The first test is to calculate the change in the monthly fixed charge and to consider mitigation if it exceeds \$4. The second is to calculate the total bill impact of the proposals in the application for low-volume residential customers (defined as those residential Regulated Price plan (RPP) customers whose consumption is at the 10th percentile for the class). Mitigation may be required if the bill impact related to the application exceeds 10% for these customers.

North Bay Hydro stated that the implementation of the transition resulted in an increase to the Espanola Rate Zone fixed charge prior to the price cap adjustment of \$4. The bill impacts arising from the proposals in this application, including the fixed rate change, are below 10% for low-volume residential customers.

Findings

The OEB finds that the proposed 2025 increase to the monthly fixed charge is calculated in accordance with the OEB's residential rate design policy. The results of the monthly fixed charge and total bill impact for low-consumption residential consumers demonstrate that no mitigation is required. The OEB approves the increase as proposed by the applicant and calculated in the final Rate Generator Model. This will be the Espanola Rate Zone's fifth year of a five-year transition period to a fully fixed rate structure for residential customers.

8. IMPLEMENTATION

This Decision and Rate Order is accompanied by Rate Generator Models, applicable supporting models, and a Tariff of Rates and Charges (Schedule A). The Rate Generator Models also incorporate the following regulatory rates and charges set out in Table 8.1.

Each of the rates is a component of the “Regulatory Charge” on a customer’s bill, established annually by the OEB through a separate, generic order. The RRRP and WMS rates were set by the OEB on December 10, 2024.¹⁴

The Smart Metering Entity Charge is a component of the “Distribution Charge” on a customer’s bill, established by the OEB through a separate order. The Smart Metering Entity Charge was set by the OEB on September 8, 2022.¹⁵

In the *Report of the Board: Review of Electricity Distribution Cost Allocation Policy*,¹⁶ the OEB indicated that it will review the default province-wide microFIT charge annually to ensure it continues to reflect actual costs in accordance with the established methodology. On November 19, 2024, the OEB issued a letter advising electricity distributors that the microFIT charge shall be \$5.00 for the duration of the 2025 rate year (May 1, 2025, to April 30, 2026).¹⁷

9. ORDER

GENERAL SERVICE 50 TO 4,999 KW SERVICE CLASSIFICATION

This classification refers to a non residential account whose average peak demand is greater than, or is forecast to be greater than 50 kW but less than 5,000 kW. Further servicing details are available in the distributor's Conditions of Service.

APPLICATION

The application of these rates and charges shall be in accordance with the License of the Distributor and any Code or Order of the Board, and amendments thereto as approved by the Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Board, and amendments thereto as approved by the Board, or as specified herein.

Unless specifically noted, this schedule does not contain any charges for the electricity commodity, be it under the Regulated Price Plan, a contract with a retailer or the wholesale market price, as applicable. In addition, the charges in the MONTHLY RATES AND CHARGES - Regulatory Component of this schedule do not apply to a customer that is an embedded wholesale market participant.

If included in the following listing of monthly rates and charges, the rate rider for the disposition of WMS - Sub-account CBR Class B is not applicable to wholesale market participants (WMP), customers that transitioned between Class A and Class B during the variance account accumulation period, or to customers that were in Class A for the entire period. Customers who transitioned are to be charged or refunded their share of the variance disposed through customer specific billing adjustments. This rate rider is to be consistently applied for the entire period to the sunset date of the rate rider. In addition, this rate rider is applicable to all new Class B customers.

If included in the following listing of monthly rates and charges, the rate rider for the disposition of Global Adjustment is only applicable to non-RPP Class B customers. It is not applicable to WMP, customers that transitioned between Class A and Class B during the variance account accumulation period, or to customers that were in Class A for the entire period. Customers who transitioned are to be charged or refunded their share of the variance disposed through customer specific billing adjustments. This rate rider is to be consistently applied for the entire period to the sunset date of the rate rider. In addition, this rate rider is applicable to all new non-RPP Class B customers.
