Re: EB-2024-0056 Tillsonburg Hydro Inc. Application for 2025 Rates

The Ontario Energy Board (OEB) provided a draft Decision and Rate Order and a draft Tariff of Rates and Charges in relation to the above-noted proceeding on March 12, 2025. On March 14, 2025, in its comments on the drafts, Tillsonburg Hydro Inc. (Tillsonburg Hydro) noted that in the draft Tariff of Rates and Charges, the rate class entitled “General Service 1,500 to 4,999 KW” should be revised to “General Service Equal to or Greater than 1,500 KW” to be consistent with previous Rate Orders issued by the OEB.

Tillsonburg Hydro also requested to specify the description of the “Rate Rider for Disposition of Global Adjustment Account – Applicable only for Non-RPP customers” be revised to read as “Rate Rider for Disposition of Global Adjustment Account – Applicable only for Class B Non-RPP customers”.

Tillsonburg Hydro noted that there were three numerical errors in the past rate rider rates, which are set to expire on October 31, 2026 due to the incorrect current tariff schedule rate inputs in the model. The different rates are:

- General Service Less Than 50 KW: Rate Rider for Disposition of Group 1 Deferral/Variance Accounts should be \$0.0021/kWh instead of \$0.0020/kWh
- General Service 500 to 1,499 KW: Rate Rider for Disposition of Group 1 Deferral/Variance Accounts should be \$0.7390/kWh instead of \$0.7123/kWh

- Unmetered Scattered Load: Rate Rider for Disposition of Group 1 Deferral/Variance Accounts should be \$0.0022/kWh instead of \$0.0021/kWh

The OEB revised the name of a Group 2 Deferral and Variance Account for the Streetlighting class for greater clarity. The name was revised from “Rate Rider for Disposition of Deferral/Variance Accounts – effective until October 31, 2026” to “Rate Rider for Disposition of Group 2 Deferral/Variance Accounts – effective until October 31, 2026” to align with the other rate classes.

The OEB has amended its Decision and Rate Order with minor revisions and has attached a revised Tariff of Rates and Charges, to reflect the above noted changes.

The OEB has now issued a final Decision and Rate Order, together with a final Tariff of Rates and Charges. Copies of these documents are enclosed with this letter.
